Farm employees become eligible for overtime, a mandatory day of rest, and the right to organize and collectively bargain. This presentation updates farms on these major legislative changes and possible strategies to remain in compliance. Other issues such as mandatory disability insurance and paid family leave will also be addressed. The new legislation also includes changes to farmworker housing regulations. Based on research with farmworkers, farmworker housing is perceived as a decisive factor for attracting and retaining skilled workers. The second part of this session will focus on housing best management practices informed by the experiences of farm workers and employers.
